Landlord reserves the right to periodically change the shuttle service schedule without notice to you.

Landlord, Security and driver reserve the right to refuse service to any individual in the event that they are a threat or nuisance to themselves, the shuttle operator or other passengers. This service is offered gratuitously, not as an amenity.
